Basix of Sassy, Inc. (SELLER"), whose principal place of business is located at 102 E.Pico Blvd, Los Angeles, CA, 90015 and person or entity that has accepted these conditions (BUYER"), AGREE AS FOLLOWS:

1. Term. This Agreement shall take effect upon acceptance by SELLER, and shall continue in effect until terminated as provided herein. BUYER's obligation to pay for Products delivered and sold shall not be limited by such termination.
2. Price and Delivery. All prices are F.O.B. SELLER's place of business. All deliveries include an original invoice, which shall be signed by BUYER upon receipt. Payment is to be made on invoice, as SELLER does not provide statements. Any freight costs and insurance, to the extent not paid directly by BUYER, shall be separately set forth on the invoice. BUYER acknowledges that all scheduled delivery dates are estimated, and that SELLER shall not be liable for any damages as a result of delays in delivery for any reason other than arbitrary refusal by SELLER to perform. SELLER retains the right to adjust prices at any time on future sales.
3. Resale Tax Certificate. Buyer agrees to provide Seller with a copy of BUYER's current resale certificate or license from time to time as SELLER may request. Failure to provide such documentation will result in the inclusion of appropriate tax assessments on purchases.
4. Buyer Agreement: Credit card purchase subject to handling fees. (**VISA, MASTER, AMEX and DISCOVER 3%**), Plus shipping.
5. Entire Agreement Amendment: No Assignment: Construction. This Agreement constitutes the entire agreement between SELLER and BUYER relating to the subject matter and supersedes all prior oral and written or contemporaneous oral negotiations, commitments and understandings of the parties. This Agreement may not be changed or amended except by a writing executed by both parties hereto. BUYER may not assign this Agreement without the prior written consent of SELLER. BUYER agrees that this Agreement shall be construed in a neutral manner, either for or against either party, regardless of the party who drafted it.
6. Governing Law. This Agreement shall be governed by and construed and enforced in accordance with the laws of the United States and the State of California as applied to agreements entered into and to be performed entirely within the State of California between California residents, and in no event shall this Agreement be governed by the United Nations Convention on Contracts for the International Sale of Goods. BUYER hereby submits to the jurisdiction of the state and a federal court located in or nearest to Los Angeles County, California, and agrees that any suit by BUYER shall be commenced in one of such courts.
7. Attorneys Fees. If any legal action is brought relating to the enforcement or interpretation of this Agreement, the prevailing party shall be entitled to recover its costs and reasonable attorneys' fees.
8. Severability. If any provision of this Agreement shall be held invalid of unenforceable, such provision shall be modified to render it valid and enforceable while to the fullest extent possible preserving the economic effect of the original provision, and the remainder of this Agreement will remain in full force and effect.
